1.1 The Role of Liberal Arts in Holistic Education

The Bachelor of Arts (BA) program at Jalna College of I.T., Jalna, is designed around the principles of liberal education, focusing on cultivating critical inquiry, cultural literacy, and civic responsibility. The Outcome-Based Education (OBE) model is fundamental to this goal, ensuring that academic rigor translates into demonstrable graduate competencies.

1.2 BA Program Outcomes (POs) and Graduate Attributes

The five defined Program Outcomes (POs) guide the BA curriculum, emphasizing skills essential for higher studies, public service, and diverse professional careers:

- PO2 and PO4 are integrated via specialized assignments, seminars, and project work across all semesters.
- **PO5** is reinforced through mandatory field study components and case studies on policy and ethics.

Chapter 4: Attainment Evaluation Methodology and Model Data

4.1 Attainment Calculation Framework

The attainment of each CO is evaluated by defining a clear target and measuring the percentage of students who meet that target across the assessment components (SEE and Internal).

- 1. **Attainment Target:** The institutional target for the BA program is 60% of students scoring 60% or above in the assessment components linked to the CO.
- 2. **CO Attainment Score:** Calculated as a weighted average of direct assessment tools:

3. **PO Attainment Score:** Calculated as the weighted average of all mapped CO Attainment Scores (using the 3-point mapping scale as the weight).

Analysis and Continuous Improvement Plan (CIP)

5.1 Attainment Analysis and Strengths

The BA program demonstrates robust success in imparting **core knowledge and critical thinking**:

- PO1 (Critical Analysis) and PO3 (Socio-Cultural Literacy) achieved High Attainment (above 70%), primarily driven by strong student performance in theory exams and content-rich assignments (CO A1, CO B1, CO C1). The program successfully builds a strong foundation in humanities concepts.
- The strong performance in CO B1 (Historical Contexts) and CO D1 (Governance Evaluation) validates the effectiveness of teaching historical and civic literacy.

5.2 Identified Areas for Improvement

The moderate attainment in PO2, PO4, and PO5 indicates areas requiring targeted intervention:

- 1. PO4 (Research Skills 59.0%): The moderate score in CO B2 (Historical Evidence) and CO D2 (Global Synthesis) suggests that while students grasp theory, they struggle with the independent tasks of source evaluation and complex information synthesis.
- 2. **PO2** (Communication 63.2%): Performance in CO A2 (Written Arguments) is only medium. Students need more formal training in advanced academic writing, referencing, and formal presentation skills.
- 3. **PO5** (Civic Responsibility 68.7%): Though close to high, this score indicates that the integration of theory into actionable civic awareness needs to be formalized (CO C2).

5.3 Continuous Improvement Plan (CIP) for 2023-24 🧩

Based on the attainment evaluation, the Department of Arts and Humanities has formulated the following actions:
